MEETING MINUTES AIRPORT NOISE ADVISORY PANEL (ANAP) 2nd Quarter 2022 Meeting Thursday, May 19, 2022 • 3:30 PM

The Committee met at the Reno-Tahoe International Airport, 2001 E. Plumb Lane, Reno Admin Offices, Main Terminal Building, Second floor as well as via Zoom Meeting. Chair Carey called the meeting to order at 3:30 p.m.

1. ROLL CALL

Since the last ANAP meeting in February, 2022, noisy and low flights have continued to harass Donner Springs and other neighborhoods adjacent to RNO. Due to some poor weather conditions, this hasn't been constant but continues nonetheless. Unlike some people who welcome warm, sunny days, I dread them because it means the flights will resume and I won't be able to peacefully use my property during the best times to do so. Today (Wednesday, 5/18/22) for example, the noise began early in the morning and kept going for several hours. Nice day outside, but not for me.

I have sent Mr. Miller several examples of extreme cases of these flights. Two of these are attached to this email.

Mr. Miller indicated to me that these flights are "standard traffic pattern operations." If that is indeed the case, ANAP needs to work with the FAA, RTAA, the flight schools and anyone else involved to get it changed. If the flight paths were set once, they can be modified to minimize the noise, safety hazards and just plain harassment created by private businesses making money at the expense of their neighbors.




