The Reno-Tahoe Airport Authority (RTAA) Purchasing and Materials Management Division, in accordance with the provisions of NRS Chapter 338 is currently accepting sealed Invitation to Bid (ITBs) from qualified Contractors per NRS §338.1382 and licensed to work in the State of Nevada to perform the reconstruction of Taxiway M and B and install a new general aviation (GA) runup area at the Reno-Tahoe International Airport and ancillary work associated with the Project, and to provide all material, labor, tools, expendable equipment, transportation services, permits and fees, utilities required, and all incidental items necessary to provide the scope of work entitled "Taxiway M/B Reconstruction and GA Run-Up Area Project."

A mandatory pre-Bid conference will be held on Thursday, March 2, 2023, at 2:00 PM in the River Room located in the baggage claim area of the Reno-Tahoe International Airport 2001 E. Plumb Lane, Reno, NV 89502. A project site tour will follow immediately after the pre-Bid conference. The purpose of the conference is to review and discuss the Invitation to Bid (ITB) Documents, including the contract drawings, specifications, and the RTAA's Disadvantaged Business Enterprise policy.

Sealed ITBs shall be opened by the RTAA Purchasing and Materials Management Division at 2:00 PM [PDT], Thursday, March 23, 2023.
