

RFQ #22/23-23

The Reno-Tahoe Airport Authority's (RTAA) Purchasing and Materials Management Division, in accordance with the provisions of NRS Chapter 332 and the Federal Aviation Administration's Airport Improvement Program, has issued this Request for Qualifications (RFQ) with the sole purpose and intent of obtaining sealed Statement of Qualifications (SOQ) Submittals from qualified, professional firms or teams to provide design services (Services) for the Concourse Development Project at Reno-Tahoe International Airport (RNO). The required Services include design work associated with the full replacement of two existing Terminal Concourses, full or partial replacement of two connector concourses, a new Central Utility Plant, airfield pavement (apron and taxiway/taxilane) work, infrastructure and utility relocation, and demolition of existing structures and pavements.

All sealed SOQs for **RFQ #22/23-23 Design Services for the Reno-Tahoe International Airport (RNO) Concourse Development Project** shall be opened at **2:00 PM [PST], March 13, 2023**.

You must first register in the NGEM Supplier System to receive RFQ solicitations. Your Supplier Registration profile will be shared with all participating government entities.

Pursuant to NRS §332.065(4), the RTAA is prohibited from entering into a contract with a company unless the contract includes a written certification that the company is not currently engaged in and agrees for the duration of the contract not to engage in, a boycott of Israel.
