## FIRST FLOOR

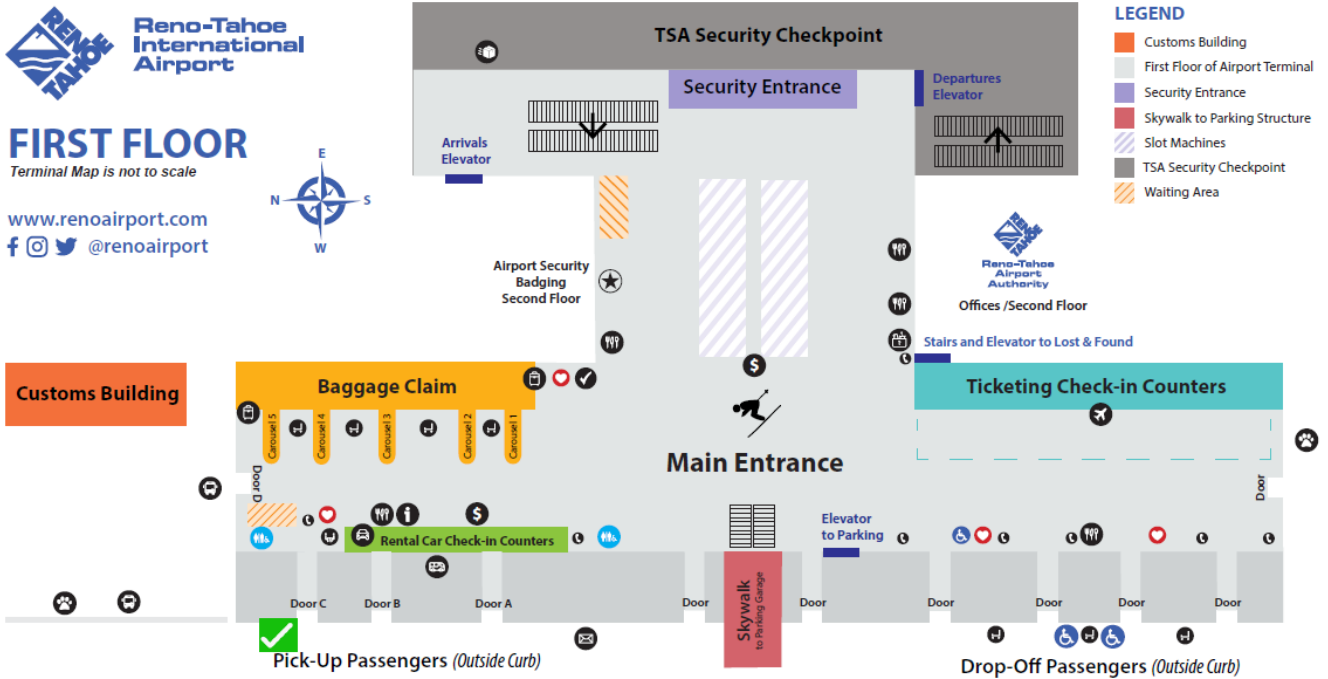
