c. Dept. of Transportation Final Rule effective May 9, 2024:

DOT DBE/ACDBE Final Rule regarding 49 CFR Part 23 & 26 Link: [DBE and ACDBE Final Rule | US Department of Transportation](#)

Highlights of upcoming changes:

- Allow virtual hearings, and on-site interviews to save recipients and firms time and money. Onsite CUF reviews on projects are still required.
- Increase of Personal Net Worth cap from \$1.32M to \$2.047M, which now excludes retirement assets.
- Interstate Certifications – upon receipt of Interstate application and receiving state confirmation with Jurisdiction of Original Certification (JOC) – formerly known as home state, that company is certified, process application within 10-business days without NUCP approval. Receive company file from JOC within 30-business days.
- Revised decertification procedures for ACDBE/DBE firms 90 days to 45 days.
- Updated rules on counting DBE Material Suppliers.
- Prompt Payment provisions and return of retainage.
- Approx. ten (10) Virtual Training sessions are scheduled by the Dept. of Transportation to go over final rule changes scheduled from April 23rd thru July 30th.
