



**RNO FRONTIER-PHX VACATION PACKAGE
SPONSORED BY THE RENO-TAHOE AIRPORT AUTHORITY**

OFFICIAL RULES, TERMS AND CONDITIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN IN THIS PROMOTION. The RNO Frontier Vacation Package (the “Promotion”) is open to all legal residents of the following Nevada counties: Carson City, Churchill, Douglas, Elko, Esmeralda, Eureka, Humboldt, Lander, Lyon, Mineral, Nye, Pershing, Storey, Washoe; and legal residents of the following California counties: El Dorado, Lassen, Nevada, Placer, Plumas, Sierra. Confirmation is subject to RTAA discretion. The promotion is open to individuals who are eighteen (18) years of age or older at the time of entry. Void where prohibited by law. Individuals employed by the Reno-Tahoe Airport Authority (the “Sponsor”) including their immediate families, may not enter or participate. Immediate family members are defined as a parent, spouse, sibling, child or anyone sharing the same residence as the applicable employee. By participating, entrants agree to be bound by these Official Rules, Terms and Conditions (the “Official Rules”) as may be modified or amended by Sponsor, and the decisions of the Sponsor, which are final and binding.

How to Enter: The Promotion begins on November 22, 2025, at 12:01 AM PT and concludes on December 12, 2025, at 12:00 AM PT (the “Promotion Period”). All entries must be submitted within the Promotion Period. Entries received after the end of the Promotion Period will be void. To enter the Promotion, participants must complete an entry form. Sponsor has no obligation to preserve or return any entry materials. By entering this Promotion, entrants give their express permission to be contacted by Sponsor by telephone, email, overnight delivery and/or postal mail for any purpose. Participants who opt in to receive future Sponsor emails regarding airport/airline information are hereby notified that personal data may be transferred and managed within the country, with the following people, companies, organizations, officials and commercial partners for publicity purposes: Sponsor.

Winner Selection, Notification, and Requirements: Subject to further verification and compliance with these Official Rules, the Sponsor will randomly select two (2) individuals and one (1) alternate from among entrants who completed and submitted

an eligible entry form during the Promotion Period. Sponsor will randomly select the Winners by 11:59 PM PDT on December 17, 2025, and contact the Winners within (2) days. Winners will receive notice of the Prize once by email and the notification will be sent to the email address provided to Sponsor at the time of entry. The identity of the Winners will be announced the week of December 15, 2025, and posted online at <https://www.renoairport.com/sweepstakes>. **ENTRANTS NEED NOT BE PRESENT TO WIN.** Winner must contact the Sponsor by no later than December 31, 2025, to acknowledge award of the Prize. In the event any Winner fails to: a) contact Sponsor by December 31, 2025; b) refuses the Prize; or c) fails to comply with these Official Rules, that Winner will be deemed to have forfeited their Prize and the Prize will be awarded to an alternate.

If a Winner forfeits their Prize, Sponsor will select the alternate to receive the Prize (upon selection, the alternate shall be deemed a “Winner” for purpose of compliance with these Official Rules) within three (3) days of a Winner’s forfeiture. After being contacted by the Sponsor, the alternate must acknowledge receipt of the Sponsor’s correspondence within five (5) days. If the Alternate fails to acknowledge receipt of the Sponsor’s contact within that time frame, refuses the Prize, or fails to comply with these Official Rules, the Prize shall be deemed forfeited and will not be awarded to anyone.

Package Delivery: Winner will be required to provide identification and sign an affidavit of eligibility; the prize will only be awarded to a verified Winner. Once a Winner’s identification is verified, the Winner must pick up their Prize at the Reno-Tahoe International Airport Administrative Offices, located at 2001 E. Plumb Lane, Reno, NV by 4:30 PM PST on Monday, January 15, 2026. If Winner refuses to execute the required documents or rejects his/her Prize, or in the event of noncompliance with these Official Rules, Terms and Conditions, the Prize will be forfeited.

If a Winner’s home address on valid driver’s license or state ID is more than 50 miles from the airport located at 2001 E. Plumb Lane, Reno NV 89502, Winner may opt to have prize package shipped to their home address.

If the actual value is less than the stated average retail value (“ARV”), difference in Prize value will not be awarded. Additional terms and conditions may apply. Terms will be provided at the time the Prize is awarded. Any Prize details that are not specified above will be determined by Sponsor, in its sole discretion. A Prize is not

transferable and not redeemable for cash except at the sole discretion of Sponsor. In the sole discretion of Sponsor, the Prize(s) are subject to change without notice, but will be substituted with a prize of equal or greater ARV. Sponsor will not replace any lost or stolen Prizes. A Prize is awarded "as is" with no warranty or guarantee by Sponsor.

Winner is responsible for making all travel arrangements. Once travel is booked, Winner shall be responsible for all other travel related expenses and change requests, including but not limited to: (i) any airfare cancellations and associated fees; (ii) any changes to the travel itinerary and associated fees; and, (iii) any changes to Winner or travel guest names and associated fees. Taxes, meals, gratuities, travel upgrades, airline baggage fees, ground transportation fees, and any other expenses not specifically listed herein are the responsibility of the Winner. Any and all hotel incidentals are the sole responsibility of the Winner. A valid credit card must be presented to the hotel for such incidentals.

The odds of winning any Prize will depend upon how many eligible entries Sponsor receives for the Promotion and are not reasonably calculable.

Limitations: One (1) entry into the Promotion per individual, per day; one (1) Prize per entrant. Attempts made by the same individual to enter the Promotion in the name of another individual will be disqualified. Sponsor reserves the right to disqualify any entrant or participant whose conduct appears in any way to inhibit the enjoyment of other entrants; violates these Official Rules; or acts in an unsportsmanlike or disruptive manner.

Sponsor reserves the right, in its sole discretion, to modify, suspend or terminate this Promotion (or any portion thereof) for any reason, including without limitation, equipment failure or malfunction, acts of God, natural causes, labor disputes, or fire, flood or other casualties.

Taxes: ALL FEDERAL, STATE, AND LOCAL TAXES ASSOCIATED WITH THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNERS. Winners will receive a 1099 tax form, when applicable, provided by Sponsor.

Verification: Winner will be required to provide identification and proof of residential eligibility.

Release: By entering, entrants agree to release, waive, and hold harmless the Sponsor from and against any and all claims, losses, damages, and liability arising from injuries (including death), damages, costs, or expenses of any kind (including without limitation attorneys' fees) incurred as a result of the entrant's participation in this Promotion and/or their acceptance, use, or misuse of any Prize or element thereof. The Sponsor is not responsible for incomplete or misdirected entries, technical malfunctions or failures, or causes beyond its control. Any attempt to deliberately damage the content or operation of this Promotion is unlawful and subject to legal action by Sponsor. The Sponsor is not responsible for printing or typographical errors or problems in any materials related to the Promotion.

Sponsor will not be required to pay any additional consideration or seek any additional approval in connection with such uses. Sponsor is not obligated to use any of the above-mentioned information but may do so and may edit such information or materials, in Sponsor's sole discretion, without further notice obligation or compensation, unless prohibited by law.

Change of Address Policy: It is the sole responsibility of the entrant to notify Sponsor if his or her contact information changes.

Disputes: Except where prohibited, each entrant agrees that: (i) all issues and questions concerning these Official Rules, shall be governed exclusively by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; (ii) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any Prize awarded (excluding air travel) shall be (A) resolved individually, without resort to any form of class action; and, (B) filed only in the state or federal courts situated in Washoe County, Nevada, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and, (iv) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special,

consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. Each entrant agrees that (i) any and all disputes, claims and causes of action arising out of or in connection with the prize described in the Prize section above or the use thereof shall be resolved individually, without resort to any form of class action, and exclusively governed by, and construed in accordance with, the laws of the State of Nevada, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Nevada or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Nevada and (ii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including associated with entering this Sweepstakes, but in no event attorneys' fees.

Severability: The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision.
