

Nevada Air National Guard - Individual Access Request

Authority: 10 U.S.C. 8013; 44 U.S.C. 3101

Purpose: This form requires collecting and maintaining information protected by the Privacy Act of 1974. Form will be safeguarded from unauthorized disclosure. Routine Uses: 152 Security Forces Squadron uses the information to determine suitability to enter the NVANG installation

Failure to include all requested information may result in denial of access to the installation.

To be a PoC/Escort, you must be a NVANG member, Dependent, or Retiree. PoC/Escort is responsible for all visitors and their actions while on the installation. PoC/Escort is responsible to notify visitors that are not granted access.

Wing CC or their designee must approve all events/visits prior to submitting Visitor List to Security Forces. **All persons over the age of 16 MUST possess a Current & Valid US Government or State Issued Photo ID. (IDs that state "Not For Federal Use" or similar, will not be accepted)**

All drivers must have in their possession a valid State (any) Driver's License, Valid Vehicle Registration and Current Proof of Insurance. Furthermore, all drivers must adhere to base driving policies (15mph Speed Limit, 100% Seatbelts, hands-free cellular devices only).

NO WEAPONS OF ANY KIND ALLOWED ON BASE.

Any non-military guests may be subject to a criminal history background check in order to ensure the following base entry criteria is met: Verify Identity, No Warrants, Not Barred From Any Federal Property, No Convictions of Sexual Assault/Rape/etc., Armed Robbery, Trafficking in Humans, Drug Possession with Intent to Sell or Distribute, any Firearm or Explosive related Felony, or any Felony (not previously listed) within the last 10 years.

Security Forces maintains the right to bar or remove any individual(s) that present a threat to the safety or security of the base, its members or guests.
